NO BUSINESS TO BE CONDUCTED PRIOR TO BUSINESS LICENSE APPROVAL.

PROCESSING OF NEW BUSINESS WILL TAKE A MINIMUM OF TWO (2) WEEKS.

(Prior to submitting your business license application, contact the Planning Department for zoning approval.)

Business license applications require prior approval from the city Building and Planning Departments. If your business is located in a commercial structure, the Building Inspector will perform a site inspection. You may also be required to contact the Lake County Fire Department at 707-994-2170 for an inspection prior to city approval. (To be determined by the Building Inspector.)

Once your business license has been approved, a copy of your application form along with your business license will be mailed to the address provided on the application form. If you prefer to pick up your license please make prior arrangements by contacting the Finance Department at 707-994-8201.

For questions concerning - Home Occupation, Zoning Clearance, Parking and Sign Requirements, Permanent and Temporary Outdoor Display or Building permits contact the Planning Department.

For merchandise sales (including wholesales, manufactures and retailers) first obtain a permit from the State Board of Equalization (707)576-2100 and submit a copy with your business license application.

When using a fictitious name (Clearlake Jewelry) in place of your sir name (John Doe= Doe Jewelry) you are required to file an application for Fictitious Business name by contacting the Lake County Auditor's Office (707) 263-2311 and submit a copy of the receipt with your business license application.

When serving food items, obtain prior approval from Lake County Environmental Health Department (707) 263-1164 prior to submitting your business license application.
